Articles of Amendment and Restatement of Articles of Incorporation of the ORPE Human Rights Advocates, Inc.

ORPE Human Rights Advocates, Inc., a Maryland nonstock corporation, hereby certifies to the State Department of Assessments and Taxation of Maryland that:

being at least 18 years of age have been elected by the members of the congregation of the ORPE Human Rights Advocates, Inc. to act as trustees in the name and on behalf of said congregation do hereby associate ourselves as incorporators with the intention of amending and restating the Articles of Incorporation of the ORPE Human Rights Advocates, Inc. and convert the Corporation to a religious corporation under the general laws of Maryland.

SECOND: The Corporation desires to, and does hereby, amend and restate in its entirely the charter of the Organization ORPE Human Rights Advocates, Inc., and does hereby, convert to a religious corporation. The following provisions are all the provisions of the Charter currently in effect, as amended and restated herein:

Article I

Name of the Religious Corporation

The name of the Organization shall be **ORPE Human Rights Advocates**, Inc.

Article II

Type

The corporation is a not-for-profit religious corporation.

Article III

Duration

The period of the duration of the corporation is perpetual.

Article IV

Address and Principal Place of Worship

The address of the principal place of worshiping is: 6701 Baymeadow Dr; Suite B;

Glen Bumie, MD 21060.

Article V

Purposes

The purposes for which the corporation is formed are stated below; and are more fully set forth in the Constitution of the ORPE Human Rights Advocates (U.S.A.):

- A congregation, and place of worship and prayer with faithful devotion to the service of our Universal Father; the God of all creation, the First Source and Center of all things and beings.
- Reveal the divine mystery to instill conscientiousness in humankind, to rescue humankind from the threats posed by the unconsciousness of this imperfect world.
- A framework of spiritual education where the mystery of Jesus' teachings should be revealed to humanity; where the consequences of these teachings should perfect humankind; where the results of perfections should lead humankind to its spiritual growth; and where spiritual growth should lead humankind in a direction where it could meet the Father Himself.
- Maintenance of divine worship: the sincere pursuit of divine values and the wholehearted love of the divine Value-Giver.
- Preserve divine truth; and reveal truth about the kingdom of heaven, which is righteousness, peace, and joy in the Holy Spirit.
- Promotion of social righteousness through instilling God-centered love, mission-centered to the services of rescuing poor, and advocating for the cause of those who cannot assert their own fundamental rights.
- Exhibit the kingdom of heaven at hand in the world, which is righteousness, peace, and joy in the Holy Spirit.
- Educate and train divine principles for the development of a new generation of change-makers-centered leadership, empowered with a higher level of spirituality and consciousness; wise enough and strong enough, and capable of changing outcomes on earth for the benefit of the salvation of humankind.

Article VI

Restrictions on Corporations Exempt from Federal Taxation

As described in the Article II above, this corporation is organized exclusively for religious, charitable, and education purposes within the meaning of section 501(c)(3) of the Internal Revenue Code." No part of the assets of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. "Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law.

Article VII

Trustees

The directors of the corporation are designated Trustees. The trustees shall be those persons who are elected, installed. They must also be eligible under civil law.

Article VIII

Officers

The Bylaws identify and provide for the method of selection or appointment of the officers of the corporation.

Article IX

Bylaws

The Bylaws of the corporation shall be in conformity with the Constitution of the ORPE Human Rights Advocates, Inc (U.S.A.), as it is now or shall be, from time to time. Amended, established, made, and declared by the authority of the ORPE Human Rights Advocates. The Bylaws will be adopted by the members of the corporation and may be amended or repealed by the members of the corporation but must at all times and all a respects remain in conformity with the Constitution of the ORPE Human Rights Advocates (U.S.A.).

Article X

Board of Trustees
